



Session Name: Missoula and Bozeman: A Tale of Two Housing Markets

Credits: 1

Presenter(s): Maggie Collister

Session Location: Mountain Combined Room

Session Description: Missoula and Bozeman have been hit hard by housing challenges in the past five years. Both have unique challenges to overcome. Low wages, a lack of housing variety, development costs and a shortage of developable land are creating challenges. On top of that, demographics are creating new demand for housing that can accommodate seniors. This session will include market data and insights, projections and case studies on some projects locally and nationally that could serve as models.

Presenter Bio(s):

Maggie Collister, has a keen eye for data, and a passion for shaping cities through commercial real

estate development. Her career began in residential development, and transitioned to economic development in Charlotte, North Carolina, with Center City Partners. She's contributed significantly to affordable housing and smart growth initiatives, leveraging her expertise in planning and consulting. At SterlingCRE, Maggie applies her data-driven approach to analyzing market conditions statewide.

Session Name: Rethinking Landscape Regulations and Wildfire

Session Description: Landscaping is one essential component of creating ignition-resistant communities. An understanding of the impacts of landscaping regulations on wildfire resiliency is essential for planners working in communities with a Wildland Urban Interface (WUI). This session is provided in partnership with Community Planning Assistance for Wildfire (CPAW), a program of Headwaters Economics.

Presenter Bio(s): Susan Riggs has uniquely experienced the public, private and non-profit sectors over the past 23 years. Her consulting firm, GroundPrint, LLC, specializes in planning, land use regulations, entitlements and urban design. One of her clients is Community Planning Assistance for Wildfire (CPAW), a program of Headwaters Economics, which provides land use planning solutions, communications assistance and customized research to better understand/manage wildfire-prone areas and reduce risks.

Session Name: Demographic and Economic Data Resources for Montana Community Planning

Session Description: This presentation will explore planning-related data resources compiled by the Montana Department of Commerce and made available through the Census & Economic Information Center. This includes best practices for utilizing publicly available population, population projections, housing characteristics, income, poverty, and community profiles for large and small communities. We will discuss data needs specific to the Montana Land Use Planning Act (SB 382) and options for improving data access.

Presenter Bio(s):

Dave Ritts is a GIS Analyst with the Montana Department of Commerce. He provides GIS support to the Census & Economic Information Center (CEIC) where he is the primary contact in the State of Montana for statistical boundary updates to the U.S. Census Geography program. He is also responsible for maintaining the CEIC data warehouse and website.

Ben Gill is an economist with the Montana Department of Commerce. He works within Commerce's Census & Economic Information Center (CEIC) where he analyzes Census data and develops dashboards. CEIC is available to assist both governmental and public partners with their data needs. He is also responsible for providing resort tax analyses and various other agency mandated reports.

Session Name: Reimagining Grant St.: Creating a Vibrant Pedestrian Corridor at Montana State University

Session Description: As Montana State University has grown to the south vehicular and pedestrian conflict along Grant St. became a major concern for the University. With several building projects in the area leading to closure of the street for construction service, the University was able to consider how the corridor could best function in the future. With the help of Sanderson Stewart and Alta Planning + Design, MSU has reimagined Grant St. as a vibrant pedestrian environment with a sustainable landscape.

Presenter Bio(s):

After obtaining degrees in Landscape Architecture and City and Regional Planning Richard spent 12 years in County Government leading development review, ordinance revisions, a comprehensive plan update, and providing representation at the Regional TPO. For the past 4 years he has served as MSU's Planning Manager leading front end planning efforts on new buildings, guiding facility assessment and Capital Planning processes, and managing the University's space assets.

Session Name: From Brownfield to New Neighborhood Center: How a Public-Private Partnerships is Transforming 10 acres in North Missoula

Session Description: After nearly 30 years of planning for redevelopment, construction activity is beginning on a portion of the former White Pine Sash facility. The master plan for the site calls for up to 220 apartments, 89 for sale homes on a Community Land Trust, and up to 35,000 square feet of neighborhood commercial, and major infrastructure investments. Hear from funding and implementation partners about how this vision came to be and why a private-public partnership is needed to make this a reality.

Presenter Bio(s):

Brittany joined the North Missoula Community Development Corporation in 2020 and leads the organization in building community power, thriving neighborhoods, and affordable homes. Brittany received an MS in Environmental Studies from the University of Montana, where she researched and wrote about settler colonialism at the National Bison Range. She serves as the Board President of the Northwest Coalition of CLTs, a regional network of community land trusts, and organizes with ProHousing Missoula, a broad-based coalition of advocates in favor of zoning code reform that leads to housing for all.

Annie has worked in the fields of community development and economic development for nearly 25 years with communities in the Caribbean, Missouri, Massachusetts, Oregon, and Montana. For the last 17 years she has worked in local government, overseeing urban renewal, job creation, and housing programs. She received her B.A. in Environmental Science and Policy from the University of Kansas and her M.A. in Community Development and Planning from Clark University.

Saddle Up...On Two Wheels: Pumping Up Active Transportation in Rural Communities

The past decade has seen dramatic gains for walking and bicycling in American cities. But what about

smaller and rural communities? Should we get in on the action? And if so, where do we start? Join us as we talk strategy for elevating active transportation in your smaller community, from gaining buyin (even from people who don't ride), developing a vision and a plan, deploying the right projects and programs, doing more with less, and plucking low-hanging fruit to keep the momentum going.

How a Digital Twin Can Inform The Planning Process

We will highlight our collaboration with the MT Department of Commerce to establish a digital twin for Lewistown, MT. Our focus will include optimizing growth, concentrating on the most appropriate areas, and ensuring compliance with the latest MT State Land Use Planning Act regulations. Utilizing Esri's ArcGIS Urban, we will craft scenarios that will be translated into an immersive 3D experience, commonly known as a Digital Twin, illustrating the city's future development potential.

Ai-driven tools for smarter planning

This session will discuss options for integrating interactive, AI-driven tools that can support various stages of a planning lifecycle. The session will highlight how AI-powered tools find practical application in a planning process, from initial citizen engagement to the final publication of AI-connected plans.

Presenter Bio(s):

Rory Renfro is HDR's Pacific Northwest Transportation Planning and Complete Streets Practice Leader. Developing creative yet practical solutions in complex environments, his portfolio includes pedestrian/bicycle master plans, corridor planning and concept design, trail feasibility studies and community engagement. Over the past two decades, Rory has worked with communities across Montana and the nation to make walking, bicycling and transit safe, reliable and enjoyable travel modes.

Robert is the GIS Integration Manager at Houseal Lavinge, bringing over 20 years of planning experience split between the public and private sectors. Robert has spent the past 15 years specializing in the implementation of geospatial technologies in urban planning and design projects and is a frequent speaker at conferences on the value of geospatial tools and the application of Geodesign in urban planning workflows that support the informed decision-making process through analysis, public engagement, and consensus building.

Session Description: Missoula's 10-acre Corner Farm Village is an innovative farmland conservation development, with an eight-acre farm and a two-acre development lot. Trust Montana will create the first community land trust farm in the state, giving a beginning farmer an affordable, secure ground lease. A farm store and café add value to the farm's production and a housing cooperative provides 12 climate-smart homes. Partners will describe tools and explain how to work within physical and regulatory constraints.
